# Observations of Academic Performance Auditors and Task Assignment

#### Prelude .

Established in the year 1961, Banki Autonomous College (hereafter, BAC), Banki is situated in the small town of Banki, in the district of Cuttack. The BAC caters to the educational needs of the rural populace. The BAC offers a wide range of choices to study in the fields of Arts, Science, and Commerce. The BAC spread over 19.67 acres of land provides a large playground, swimming pool, indoor stadium, and gymnasium. The BAC has a canteen, a post office, five separate hostels for girls and boys, a medical consultancy and care unit, a two-storeyed guest house, a Principal's quarters, and 12 staff quarters for teaching staff. It has adequate infrastructure facilities for academic, administrative and socio-cultural activities

The BAC offers an honours program in 23 subjects of Arts, Science, and Commerce and P.G. programs in 12 subjects. The college is successfully running the study Centre of Odisha State Open University (OSOU), Sambalpur. In addition, the BAC offers six self-financing programs through PPP mode.

The college obtained the autonomy status in 2006-2007. It was recognized by UGC as a College with Potential for Excellence (CPE) in 2010. It was assessed by the NAAC for the first time on 10.02.2007 and accredited with a B<sup>++</sup> grade. The NAAC assessed the college again for its 2<sup>nd</sup> cycle on 01.05.2019 and was accredited with a B<sup>++</sup> grade (CGPA - 2.87). Now the college is gearing up for the 3<sup>rd</sup> cycle of accreditation as the validity of the previous accreditation is up to April 30, 2024. BAC has a challenging aspiration to upgrade itself to Banki Rural University which resonates with the dream of its founder, Dr. Jogesh Chandra Rout.

# 1(a) Adequacy of SWOC [in about 100-150 words]

SWOC analysis helps the HEI to ascertain its strengths, weaknesses, opportunities, and challenges. The BAC has tried its best to draft the SWOC, but

the SWOC suffers from contradictions and conflicts and inappropriate inclusion of components in the matrix. Say for example, 'Moreover, the dream of Dr. Jogesh Chandra Rout, the founder of the college is to be achieved, i.e., "Banki Rural University" cannot be considered as a component of the Opportunities. Rather, it should be placed under the category, 'Challenges.' Similarly, 'Standardization of Processes for Documentation' cannot be considered under the category, 'Challenges'. A drastic revision of the SWOC analysis is recommended. The SWOC analyses presented by the Head of the HEI were different from those written by the Coordinator of the IQAC in the designated Excel format.

# 1(b) Performance Index [in about 100-150 words]

An academic performance index  $\geq 0.6$  is considered satisfactory. The median API score for BAC is not as healthy as it stood at 0.25. The Political Science Department scored the highest (0.33) and the Department of History has the lowest API (0.12). Individually, not a single department could score more than 0.33 API. The current status of the HEI could be attributed to low faculty-centric metrics, limited infrastructural additions, and poor academic-related activities. The low research output of the faculty in the form of publications in UGC-CARE journals also contributes to the low API.

# 1(c) Benchmarks and timeline [in about 100-150 words]

The BAC did not take any initiatives regarding benchmarks and the institution's attainment in compliance with their own or NAAC's benchmark has never been reviewed. The HEI did not identify the KPIs. Therefore, this audit team is unable to observe and review the timelines. The BAC has planned to submit the SSR for the 3<sup>rd</sup> Cycle of NAAC accreditation on or before April 2024. However, the HEI has yet to submit the AQAR for 2019-20 to 2021-22.

## 1(d) Performance of library [in about 100-150 words]

The Banchhanidhi Library of the BAC holds about 51470 textbooks and 1560 reference books. In the Book Bank, it has 1485 books. The library subscribes to about 20 journals in various subjects. Access to the N-List resources has expired and the college did not take any initiative to renew to get access. The library page on the website does not provide a link to access NDL. The transactions of the books at the library are not fully automated although the librarian claimed that the LMS 3.0 is being used. The library does not maintain a record of the month

wise footfall. The library has not prepared a list of books that have never been issued by any beneficiaries. The library has not circulated the credentials to access the EBSCO among the students. The link to EBSCO has not been uploaded on the web pages of the BAC.

#### 1(e) Functioning of IQAC [in about 100-150 words]

The IQAC of BAC is active and it was established on 11.07.2007. The college has already completed its 2<sup>nd</sup> NAAC accreditation and getting itself ready for the 3<sup>rd</sup> NAAC accreditation. However, in the academic year (2022-2023) under the review, the IQAC organized only two meetings. The IQAC did not organize any workshop under the title Research Methodology, IPR, and Entrepreneurship. There is a need to conduct at least eight workshops in the above areas per year. The IQAC did not take any initiative to constitute an Institutional Ethics Committee (IEC) regarding the use of Animals, Chemicals, and Bioethics. The IQAC did not take any initiative to ensure that the faculty are engaged in offering consultancy in the areas of their expertise. The BAC does not have a policy on plagiarism and faculties are unaware of the 'DrillBit-Extreme Plagiarism Detection Software' offered by the INFLIBNET Centre to all Higher Education Institutions (HEIs) as part of the ShodhShuddhi initiative. The full-fledged service of the 'DrillBit-Extreme Plagiarism Detection Software' commenced on November 1, 2023. Many mandatory audits have not been conducted by the IQAC in the year under review.

# 1(f) About the Website and Digital Footprint of the HEI [in about 100-150 words]

The website of BAC is not NAAC compliant. For example, the sub-tab 'Best Practices' under the main tab 'Activities' does not reflect any information. The button with the link 'download' does not work. The story is the same for most of the tabs. The website does not exhibit any data.

The digital footprint of the HEI is not up to the mark. In the affiliation search, the HEI is not visible in the databases, such as WoS and Scopus. The teachers of the BAC published 20 research papers in the academic session 2022-2023. However, the home page of the journals and the link/DOI number of the publications have not been uploaded to the website. Most of the faculty of the HEI have not registered in important academic databases, such as Google Scholar, Publons, ResearchGate, ORCID, Vidwan, etc.

Toy

The logos of Facebook, X, Instagram, and YouTube have been embedded on the Home page of the website of the HEI. Unfortunately, except for X (previously Twitter), no other social media platforms have updated information. The followers of these platforms are limited (Instagram -13 followers; X-109 followers; Facebook -0 followers, and YouTube -0 followers).

# 1(g) Status of examination and confidential section [in about 100-150 words]

The Audit Team had an elaborate discussion with the CoE of the HEI. The HEI has not registered itself with the NAD platform and the HEI has not been onboarded with the ABC platform. The CoE uses Academia — an examination management system to manage its activities. The final result is published within 45 days after the completion of the examination. The CoE analyses the students' results program-wise, but not course-wise. The UG and PG toppers of all subjects are felicitated and conferred with medals by the guests on the convocation day.

### 1(h) Status of sports and games [in about 100-150 words]

The BAC has adequate infrastructure for sports activities and games. The HEI has volleyball, football, and basketball courts. The BAC has a gymnasium that caters to the students. It is evident from the record that a large number of students participate in many sports and games activities at the university, state, and national levels. The BAC has a swimming pool. However, information on sports and games in the year under review has not been published on the web pages of the college.

## 1(i) Status of other central facilities, if any [in about 100-150 words]

The BAC does not have a central instrumentation facility. The BAC has a canteen that serves the needs of the students, teachers, and other employees of the college. The college has a training Center for promising athletes. The college on its campus has a Bank ATM and a Post Office. The college has a central library [see above at 1(d)] and a gymnasium and other sports and games facilities [see above at 1(h)].

# 1(j) Status of NCC/NSS/YRC/Rovers and Rangers/Others, if any [in about 100-150 words]

The NCC/NSS/YRC/Rovers and Rangers wings of the College are active. These wings take part in Government-sponsored programs, like *Swachha Bharat* 

Abhiyan, International Yoga Day, the survey of the literacy program, awareness drives, afforestation drives, and health check-up programs for the benefit of the people in the surrounding villages. The blood donation program is organized twice every year. The NSS unit of the BAC was actively involved in arranging blood donation camps. The NSS unit plants saplings in and around the campus of the college every year.

# 1(k) Task assignment [Up to 10 bullet points]

- The BAC should offer Add-On, Certificate, and Value-Added courses with course modules and outcomes. Each course should be of at least 30 contact hours. Each department of the HEI should offer two such courses to provide students with additional skills and knowledge that are relevant to their field of study.
- The time lag between the day of the completion of end-term examinations and the date of declaration of results should be <20 days.
- The HEI should provide seed money to teachers for conducting research. The total annual funding should be to the tune of ≥ INR 20.0 lakh. A research promotion policy should be drafted and implemented as soon as possible.
- The teachers should be motivated to mobilize grants from extra-mural funding agencies, and government and non-government agencies.
- The teachers should be encouraged and incentivized to publish research papers in Scopus, WoS, and UGC-CARE journals only. The eligible teachers should be encouraged to register themselves as PhD supervisors.
- All teachers should register themselves using institutional email IDs in academic databases, such as Google Scholar, Publons, ResearchGate, ORCID, Vidwan, etc.
- The institution should set up a central instrumentation facility for the research students and teachers as early as possible.
- The BAC should strengthen the Career Counselling and Placement Cell at the earliest. The HEI should carry out the graduate exit and employer surveys regularly.
- An industry-academia partnership cell should be created and activated to enable work-ready students to gain specialist knowledge and practical training. MoUs should be signed with peer institutions in India and abroad for student and faculty exchanges and collaborative research.


The BAC should work aggressively to establish an Alumni Connect Cell.
 Through this cell, it should augment Alumni Engagement in its academic and infrastructural development plans and programs.

# 2 Detailed Report [No word restriction]

#### Academic Performance Index

Academic Performance Index (API) reflects the overall academic activities of a department and also of the HEI. The API score ranges between 0.0 and 1.0. The API scores of 22 departments of Banki Autonomous College varied between 0.12 and 0.33. The Department of History obtained the lowest score, whereas the Department of Political Science obtained the highest score. The API score obtained by each department has been depicted in Table 1. The deviations of each department's score from the median have been presented in Figure 1.

Figure 1: Cartoon diagram illustrating the deviations of the department's API score from the Median Score for the BAC



The departments, namely Botany, Biotechnology, Commerce, Education, Geology, Home Science, Political Science, Physics, and Sanskrit scored above the median value of 0.25 (API). The departments, such as Economics, Computer Science, English, Geography, History, Odia, Philosophy, Psychology, Sociology,

and Statistics scored below the median API. The API scores of three departments, namely Chemistry, Mathematics, and Zoology scored the same as that of the median API.

The lower scores of each department and the BAC are attributed to the poor faculty-centric metrics, infrastructural additions in the year under review, and academic-related activities.

## General Advisory to the HEI

- It is recommended that the HEI identifies one or two very important distinctiveness for the institution.
- Mention only two Best Practices of the HEI and present those in the NAAC-recommended format.
- Introduce new courses across all programs offered to the students.
- Ensure that the students get benefits from the online MOOC programs, like SWAYAM, NPTEL, etc.
- Ensure that all programs offered by the HEI have field projects, research projects, and internships as mandatory components.
- Ensure that feedback collected from all stakeholders is analyzed, action taken, and communicated to relevant bodies and hosted on the web pages of the HEI.
- Ensure to maintain a PTR <20:1.
- Constitute Institutional Ethics Committee.
- Conduct a plagiarism check on all academic documents, such as project reports, dissertations, theses, and research papers using 'DrillBit-Extreme Plagiarism Detection Software which is freely provided by INFLIBNET to all HEIs of our country.
- Draft and implement Plagiarism policy, IPR policy, Research policy, etc.
- Augment the frequency of outreach programs through NCC/NSS, etc.
- Increase the number of functional MoUs and collaborations/linkages with peer institutions.
- Ensure that all faculties and students maximize the use of e-resources available on the EBSCO platform. This facility has been extended to all Autonomous Colleges by the Government of Odisha, Department of Higher Education.
- Increase the frequency of sports events, cultural events, and technical/educational fests.
- Implement e-governance in HEI's operations, such as administration, finance, accounts, student admission and support, and examination.
- Extend financial support to the faculty for attending seminars/ symposia/ conferences, workshops, and FDP.
- Conduct AAA regularly.
- Participate in NIRF and prepare for the India Rankings 2025.
- Identify and implement quality improvement initiatives.

- Take appropriate measures for facilities directed toward alternate sources of energy, energy conservation, and water conservation.
- Conduct environment audits and energy audits regularly.
- Make the campus friendly for differently-abled students, faculties, and employees of the HEI.
- A policy on the prevention of sexual harassment and ragging should be drafted and implemented.
- Ensure that no one spits and dribbles on the walls of the buildings.
- The IQAC should conduct at least one meeting per month.

#### General Advisory to the Departments

- The advisory mentioned herein is very specific to the departments. Read this in conjunction with Task Assignment at 1(k) on Page 5 and General Advisory to the HEI on Pages 7-9.
- Each department should develop an instrument to identify slow and fast learners. Thereafter, the concept of peer teaching could be practiced.
- None of the departments offered skill enhancement courses.
- In the year under review, none of the faculty of any teaching department had any ongoing research project. All faculties should be motivated to write research projects and submit them to different funding agencies for grants.
- Steps to be taken to increase the number of PhD supervisors on the campus.
- Not a single department offered consultancy. There should be a dedicated page on the HEI's website earmarked for Consultancy. Each faculty's areas of expertise should be identified and published on this page highlighting the areas wherein the faculty can offer consultancy.
- Each department should take the initiative to augment alumni engagement and contributions from them.
- The proceedings of parent-teacher and mentor-mentee meetings should be prepared and published on the web pages. Each department should carve out space for regular mentor-mentee meetings in the timetable.
- Each department should carry out outreach activities (at least two each year) independently of those carried out by NCC/NSS, etc.
- The faculty of each department should work in collaboration with faculty at the peer institutions.

#### **Concluding Remark**

The Academic Performance Audit Team appreciated the enthusiastic participatory role of the Principal, BAC in the process of audit. The faculty and

non-teaching staff of BAC actively participated in the successful completion of the Academic Performance Audits. They extended their unreserved support to the members of the Audit Team.

Although the BAC has adequate infrastructure facilities, it requires upgradation and expansion. Many gray areas need to be addressed and resolved. The BAC should introduce the concept of finishing school as soon as possible. More emphasis should be on research, fund mobilization, strengthening alumni engagements, student support, and industry-academia partnerships. The digital footprint of the BAC should be augmented extensively. The specific areas wherein the BAC should concentrate have been underscored at 1(k) on Page 5 (Task Assignment), Pages 7-9 (General Advisory to the HEI), and Page 9 (General Advisory to the Departments). The Audit Team interacted with all stakeholders, especially faculty and employees of the BAC before drafting this Performance Audit Report.

The Audit Team wishes a very bright future for the Banki Autonomous College, Banki, Cuttack.


