RESOLUTION


Directorate of Indian Medicines and Homoeopathy, Odisha was functioning permanently vide Health & F.W. Department Resolution No. 8809/H., dt. 22.03.1982. In the meantime Govt. of India have changed the name of Department of Indian system of Medicines and Homoeopathy to Department of AYUSH(A-Ayurveda, Y-yoga & Naturopathy, U-Unani, S-Siddha, H-Homoeopathy) vide their Notification No. 1/22/1/2003-Cab (1) dt.11.11.2003. Accordingly, keeping in view the growing importance of AYUSH systems, it was under active consideration of Govt. to change the name of Directorate of Indian Medicines and Homoeopathy, Odisha to Directorate of AYUSH, Odisha on the analogy of Notification issued by the Govt. of India.

After careful consideration, Govt. have been pleased to change the name of **Directorate of Indian Medicines and Homoeopathy, Odisha to Directorate of AYUSH, Odisha**. Accordingly, **Director of Indian Medicines & Homoeopathy, Odisha will be renamed as Director, AYUSH, Odisha** on the same analogy.
